- (a) A letter shall be dispatched in writing and by registered post, by hand or by any other means available to the neighbours along the street frontage of the subject erf and all other owners / occupants on the same subject erf, if applicable, informing the neighbours of the intent of the owner;
 - (aa) Full details of the application including, but not limited to, the street address, the name of the township, a clear erf description of the erf concerned and the nature and general purpose of the application with being applied for;
 - (bb) The date on which such application was submitted to the City and it shall reflect the name, postal address, telephone number, fax number and e-mail address of the person submitting the application; and
 - (cc) That any objection, comment or representation in regard thereto must be submitted timeously to both the City and the person mentioned in subsection (bb) above in writing by registered post, by hand, by facsimile or by e-mail within a period of 28 days from date of notification.
- (b) Proof of compliance with the above in the form of a written **affidavit** shall be submitted to the City within 14 days of expiry of the date contemplated above.
